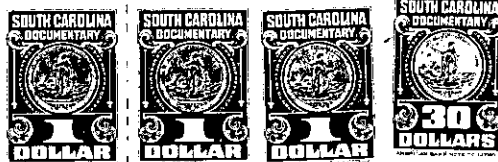

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate lying and being on the north side of Lee Haven Court, near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 30, on Plat of Barbrey Heights, Section 2, which plat is recorded in the RMC Office for Greenville, S.
