the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Martha Joan H. Foster, her heirs and assigns, forever:

All that piece, parcel or tract of land in Butler Township, County of Greenville, State of South Carolina, on the waters of Enoree River and shown as a 17 acre tract on a plat prepared by Carolina Surveying Company on May 17, 1972 and according to said plat, having the following metes and bounds, to-wit:
