unto SHERRILL GRIFFIN, his heirs and assigns forever:

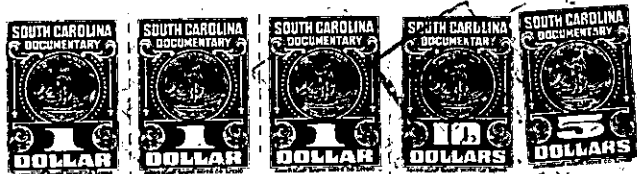
