Horace Knight and Joyce Knight, their heirs and assigns forever,

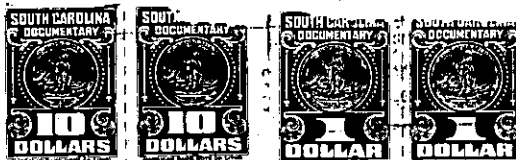
All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as Lots Nos. 4 and 5 of Block E, as shown on plat of Riverside, recorded in Plat Book K at Page 281, and being more particularly described according to said plat as follows:

"Beginning at an iron pin on the South side of Palmetto Street, joint front corner of Lots 5 & 6, which pin is 314 feet West of the Southwest intersection of Palmetto and Sumter Streets, and running thence with joint line of said lots, S. 10-15 W. 125 feet to an iron pin in a 15 foot alley; thence with said alley, N. 79-45 W. 100 feet to an iron pin; joint rear corner of Lots Nos. 3 and 4; then with joint line of said Lots, N. 10-15 E. 125 feet to an iron pin on the South side of Palmetto Street; thence with said Street, S. 79-45 E. 100 feet to the beginning corner."
