All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the northwestern side of Douglas Drive, being known and designated as Lot No. 6, as shown on a Plat of Martindale, made by C. O. Riddle, June, 1959, and recorded in the R. M. C. Office for Greenville County, in Plat Book BBB, at Page 97, and having, according to said Plat, the following metes and bounds, to-wit:
