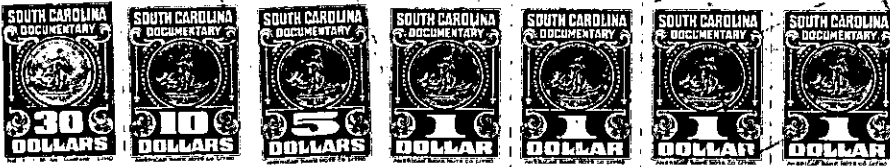

M. C. Office for Greenville County, in Plat Book "GG", at Page 187, and having, according to said Plat, the following metes and bounds, to-wit:
