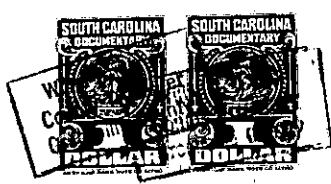
in consideration of One Thousand (\$1,000.00) Dollars,
