NOW, Therefore, Know all Men by these Presents, that I, FRANK P. McGOWAN, JR., as Master, in and for the County of Creenville aforesaid, by virtue of the aforesaid decree, and consideration of \$444.44,

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Joe W. Jones and Ruth Jones:

All the right, title and interest of Wayne J. Stanton, a minor, the same being an undivided two-ninths (2/9ths) interest, in and to the following described property:

ALL that certain piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, and being more particularly described as follows: BEGINNING at a point on the west side of S. C. Highway No. 247 (old Cooley Bridge Road) at corner of property of Montez Loftis, and running thence with said highway S 1-30 W 330.6 feet to the intersection of said highway and Beech Springs Road; thence with said road S 82-00 W 201.3 feet to a point; thence N 62-00 W 182 feet to a point in an old road; thence with said old road N 7-50 E 307.4 feet to a point in dirveway corner of said property of Montez Loftis; thence with said driveway and line of Montez Loftis property S 84-00 E 327.3 feet to the beginning corner, and containing 2.77 acres, more or less.

This is the identical parcel of land conveyed unto John E. Loftis by deed of S. A. Cooley dated January 16, 1915, of record in the Office of the Register of Mesne Conveyances for Greenville County, South Carolina, in Deed Book 35, at Page 85, the said John E. Loftis having subsequently died intestate leaving as his sole heirs at law and distributees, a son, Archie D. Loftis; a granddaughter, Montez Loftis, who is the daughter and sole heir at law of John B. Adger Loftis, a deceased son of John E. Loftis; and a daughter, Lucille L. Stanton; the said Archie D. Loftis and Montez Loftis having conveyed their interest in the above described parcel of land unto Wilson J. Stanton and Lucille L. Stanton by deed dated December 19, 1959,
