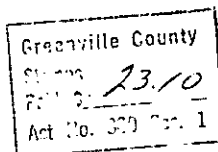
KNOW ALL MEN BY THESE PRESENTS, that American Development, Company, a Partnership organized under the Uniform Partnership Act of South Carolina
