KNOW ALL MEN BY THESE PRESENTS, that We, John Henry McDaniel, Jr. and Alvin G. McDaniel

in consideration of One and No/100 (\$1.00)-----Dollars,
and other valuable consideration
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto

T. Walter Brashier a one-fourth (1/4) undivided interest; H. L. Rosamond a one-third (1/3) undivided interest; I. H. Philpot a one-fourth (1/4) undivided interest and S. A. Philpot a one-sixth (1/6) undivided interest, their heirs and assigns forever, the following described real property:

All that tract of land in Bates Township, Greenville County, S. C., containing 65 1/2 acres, more or less, according to a survey and plat made by W. A. Hester, Surveyor, on January 17, 1916, revised June 10, 1947, and recorded in the R. M. C. Office for Greenville County in Plat Book U at page 83, reference to which is hereby made and having the following metes and bounds:

Beginning at an iron pin on the White Horse Road and running thence with said road N. 5 1/2 E. 14.30' to pin on White Horse at intersection of White Horse Road and Keeler's Mill Road; thence with the Keeler's Mills Road N. 80 3/4 W. 11.15' to stone off said road; thence N. 66 1/4 W. 7.68' to iron pin; thence S. 44 1/4 W. 22.60' to iron pin; thence S. 45 E. 23.00' to iron pin in middle of road; thence with said road N. 81 1/4 E. 3.30' to bend in said road; thence N. 68 E. 5.40' to intersection of said road with road leading from White Horse Road to Keeler's Mill Road; thence with the latter road S. 51 E. 3.00' to stake on side road; thence N. 20 E. 4.00' to beginning.

ALSO:

All that lot of land in Greenville County, South Carolina on the northwestern corner of the intersection of the Ledbetter Road and the new course of the White Horse Road, being a roughly triangular strip of land, bounded on the East by the White Horse Road in its new course, on the South by the Ledbetter Road, on the West by property of Grantor and coming to a point on the North. It is the intention of Grantors to convey all the triangular strip of land lying between the old and new course of White Horse Road, northerly from Ledbetter Road, including the portion of old course of White Horse Road owned by Grantors.
