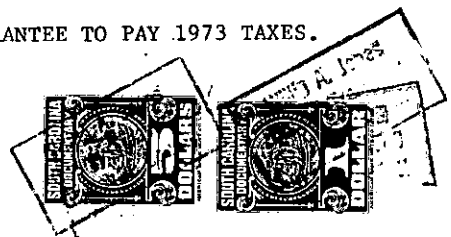
An undivided one-third (1/3) interest in and to all that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northwesterly side of Chippendale Drive, near the City of Greenville, S. C., being known and designated as Lot No. 64 on plat entitled "Final Plat Revised, Map No. 1, Foxcroft, Section II", as recorded in the RMC Office for Greenville County, S. C. in Plat Book 4N, pages 36 and 37, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Chippendale Drive, said pin being the joint front corner of Lots 63 and 64 and running thence with the common line of said lots N 62-11 W 173.6 feet to an iron pin, the joint rear corner of Lots 63 and 64; thence S 45-21 W 149.3 feet to an iron pin, the joint rear corner of Lots 64 and 66; thence S 53-22 E 88.6 feet to an iron pin, the joint rear corner of Lots 64 and 65; thence with the common line of said lots S 83-31 E 160 feet to an iron pin on the northwesterly side of Chippendale Drive and thence with the northwesterly side of Chippendale Drive N 11-57 E 50 feet to an iron pin; thence continuing with said Drive N 22-56 E 50 feet to an iron pin, the point of beginning.
