BIGGERS AND PATRICIA B. BIGGERS, THEIR HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land situate, lying and being in Grove Township, Greenville County, South Carolina, designated as Lot No. 13, Section 2 of Belle Terre Acres, plat dated June 5, 1969, recorded in the RMC Office for Greenville County in Plat Book 4-F at Pages 8 and 9, containing 2.04 acres, more or less, and having the following courses and distances:

BEGINNING at an iron pin on the Southern side of Greenleaf Lane at the joint corner with Lot No. 14 and running thence S. 35-10 W. 287.1 feet to an iron pin; thence S. 48-57 E. 140 feet to an iron pin; thence S. 61-31 E. 195 feet to an iron pin; at the rear corner of Lot No. 12; thence N. 22-45 E. 295 feet to an iron pin on Greenleaf Lane; thence along said Lane N. 60-13 W. 100 feet to an iron pin; thence N. 57-17 W. 100 feet to an iron pin; thence N. 51-27 W. 70 feet to the point of beginning.

THIS property is subject to the protective covenants recorded in the RMC Office for Greenville County in Deed Book 711 at Page 181, Deed Book 761 at Page 77, and as amended in Deed Book 822 at Page 508. In addition thereto, no goats, pigs or chickens shall be kept, produced or raised on said property. 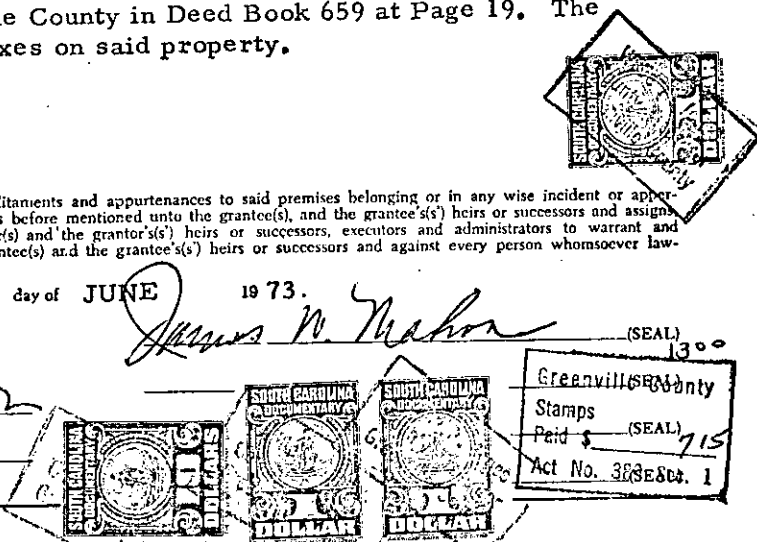
