DORIS JAMES WOODWARD, her heirs and assigns forever:

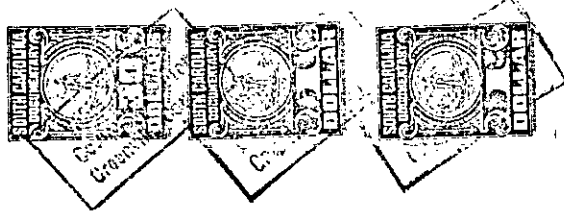
