the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto BLUE RIDGE CORPORATION, its successors and assigns,

ALL that parcel or tract of land situate and being in the dismal area between Caesar's Head and Table Rock west of the Geer Highway in Cleveland Township, Greenville County, South Carolina, being shown on plat recorded in Plat Book Y, at pages 114-118 as a portion of the 737 acres No. A-III Thomas Wilson (Guignard) and containing 350 acres and being described as follows:

BEGINNING at a point in Matthews Creek and running thence N. 67-39 E. 38.34 chains to an iron pin; thence N. 19-42 W. 34.18 chains to an iron pin; thence N. 21-27 W. 40.17 chains to an iron pin; thence continuing N. 21-27 W. 22/452 chains to an iron pin; thence S. 67-52 W. 28.38 chains to an iron pin; thence S. 19-51 E. 25.11 chains to an iron pin; thence S. 70-10 W. 18.49 chains to a point in Matthews Creek; thence down Matthews Creek following the meanders thereof approximately 75 chains to the beginning corner.

Together with any and all easements over property of others the grantor may have for ingress or egress to and from this property to a public road.

This conveyance is subject to all restrictions, set-back lines, roadways, easements and rights of way, if any, affecting the above-described property. This lot is shown on the Greenville County Block Book as Sheet 686.2, Block 1, Lot 1.
