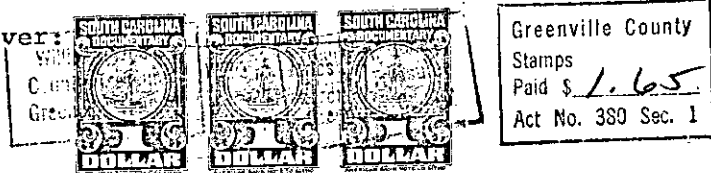

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by  
these presents do grant, bargain, sell and release unto the said LARRY WILLIAMS, his  
heirs and assigns forever:



all that piece, parcel or lot of land in Greenville Township, Greenville  
County, State of South Carolina, being known and designated as Lot 183 of  
Pine Forest as shown by a plat thereof, made by Madison H. Woodward,  
Engineer, having the following metes and bounds, to-wit:

BEGINNING at an iron pin joint corners of Lots Nos. 183 and 184 and  
running thence S. 86-16 E. 200 feet to an iron pin; thence N. 1-52 E.  
109.4 feet to an iron pin on street; thence S. 79-44 W. 200 feet to  
iron pin on Charles Drive; thence along said Charles Drive S. 3-44 W.  
61.3 feet to point of beginning. -155-421-5-1

ALSO, all that piece, parcel or lot of land being known and designated

an iron pin on the east side of Charles Drive, joint corner of Lots  
184 and 183; thence with the line of Lots 184 and 183 S. 86-16 E. 200  
feet to an iron pin on the line of Lot 250; thence with the line of Lots  
250, 259 and 184 S. 3-44 W. 60 feet to an iron pin in the line of Lot  
259 and at joint rear corner of Lots 184 and 185; thence with the  
line of Lots 185 and 184 N. 86-16 W. 200 feet to an iron pin on Charles
