ALL water lines, mains, valves and appurtenances installed and located in, under or along Old Mill Road, Heather Lane, Oak Park Drive, Oak Park Court, Barrett Drive, Barrett Court, McSwain Drive and Libby Lane, County of Greenville, State of South Carolina, including approximately 2,811 feet of 8 inch pipe, 1,847 feet of 6 inch pipe, 2,834 feet of 2 inch pipe, 1 - 8 inch valve, 9 - 6 inch valve, 10 - 2 inch valves, and 6 Fire Hydrants, and shown on a drawing entitled "Martha F. Burdett, W. M. Burdett and Della B. McKinney to Commissioners of Public Works of the City of Greenville, S. C., May 3, 1973" attached hereto and made a part of this conveyance.
