

All the rest, residue and remainder of my interest the same being in an undivided one-half interest in and to all that piece, parcel or lot of land in the city of Greenville, Greenville County, South Carolina, on the northwest side of Davis Street, and being known and designated as Lot No. 25, of a subdivision known as Sans Souci Park, as shown on plat thereof recorded in the R.M. C. office for Greenville County in Plat Book C, at page 158, and also shown on the Township Block Book at Page 170, Block 4, Lot 6, and being more particularly described as follows, to-wit:
