JIMMIE C. HALL and SHERRYL O. HALL, their heirs and assigns forever:

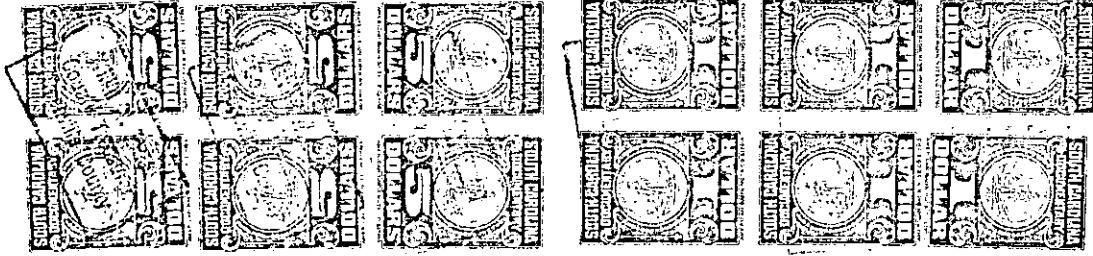

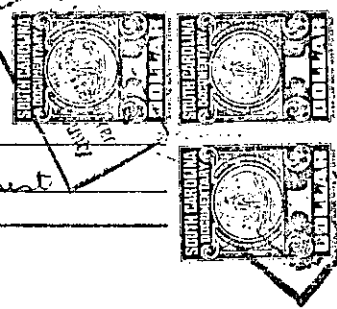
