ALSO: All the right, title and interest in and to the 15 foot alley lying between the rear lines of the lots hereinabove described.

This conveyance is subject to all restrictions, setback lines, roadways, easements, rights-of-way, if any, affecting the above described property.

The purchase price which the Buyer shall pay for the said property is the sum of Nine Thousand, Nine Hundred and Ninety-Five and No/100 (\$9,995.00) Dollars, which sum shall be paid as follows: In monthly installments of \$121.33 each, beginning on I February, 1973, the deferred payments to bear interest at the rate of eight (8%) per cent per annum, with entire balance due and payable on the 10th day of January, 1983.

The Buyer agrees to my the said purchase price of said property in the manner and at the time above set forth, time being declared of the essence of this contract, and in the event of sixty (60) days default by the Buyer in making any of the payments herein provided for, then, at the option of the Seller all rights and interests of the Buyer under this Agreement may thereupon be declared terminated by the Seller, and in such event all money paid by the Buyer under the provisions of this agreement may be retained by the Seller as rental or liquidated damages of said property, and said contract shall thereafter be
