REAL PROPERTY AGREEMENT

In consideration of such loans and indebtedness as shall be made by or become due to THE SOUTH CAROLINA NATIONAL BARK OF CHARLESTON (hereinafter referred to as "Bank") to or from the undersigned, jointly or severally, and until all of such loans and indebtedness have been paid in full, or until twenty-one years following the death of the last survivor of the undersigned, whichever first occurs, the undersigned, jointly and severally, promise and agree

- 1. To pay, prior to becoming delinquent, all taxes, assessments, dues and charges of every kind imposed or levied upon the real property described below; and
- 2. Without the prior written consent of Bank, to refrain from reating or permitting any lien or other encumbrance (other than those presently existing) to exist on, and from transferring, selling, assigning or in any manner disposing of, the real property described below, or any interest therein; or any leases, reats or funds held under escribed agreement relating to said premises; and
- 3. The property referred to by this agreement is described as follows: BESTRIMED at an iron pin on the northern side of Glenn Road; joint front corner Lots Nos. 22 and 23, and running thence with the joint line of said lots N 3-10.E. 262.5 feet to an iron pin on the line of property known as Green Acre; thence with said Green Acre line S. 87-30 E. N8.5 feet to a point in the center of Not No. 22; thence with a new line through the center of Lot No. 22 approximately S. 3-30 W. 209.5 feet, more or less, to an iron pin on the norbern side of Glenn Road; thence with Glenn Road S. 77-15 W. 50 feet to the beginning corner; and being a portion of the same property conveyed to me by Annie T, Henderson, by deed dated June 29, 1956, and recorded in the R.M.C. Office for Greenville County in Deed Vol. 557 at Page 170.

That if default be made in the performance of any of the terms hereof, or if default be made in any payment of principal or interest, on any notes hereof or hereafter signed by the undersigned, the undersigned agrees and does hereby assign the rents and profits arising or to arise from said premises to the Bank and agrees that any judge of jurisdiction may, at chambers or otherwise, appoint a receiver of the described premises, with full authority to take possession thereof and collect the ronts and profits and hold the same subject to the further order of said court.

- 4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebtedness then remaining unpaid to Bank to be due and payable forthwith.
- 5. That Bank may end is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places as Bank, in its discretion, may elect.
- 6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, end until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and easigns, and inure to the benefit of Bank and its successors and assigns. The affainant of any officer or department manager of Bank showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
