- To refine, distill, manufacture, process, market, buy, sell and otherwise deal in medicinal products, insecticides, fungicides, rodenticides and specialties of all kinds and compounds and combinations thereof.
- 3. To engage in or to carry on for others engineering, chemical, physical, or any other scientific research or development work; to investigate, test, develop, produce, demonstrate and license new chemical processes; to use and operate such processes and to sell or otherwise exploit or dispose of the same; to sell, use or otherwise dispose of any products made by any such new chemical processes; to manufacture, produce, sell and otherwise deal in chemicals, organic and inorganic, of all kinds, gases, solids, liquids, and any and all combinations thereof.
- 4. To produce, acquire, manufacture, process, transport, own, hold, encumber, sell or otherwise dispose of, and otherwise deal in equipment, commodities, materials, goods, wares and merchandise and personal property of every kind and description.
- 5. To acquire, own, hold, construct, manage, to sell, mortgage, lease and otherwise dispose of, and to deal in and operate mines, refineries, bulk and retail gasoline stations, factories, gas works, tanks, tank cars, bridges, wharves, warehouses, repair shops, power plants, telephone and telegraph lines, radio stations and other communication equipment, all kinds of machinery and equipment, office buildings and any and all other property, structures, facilities, building materials and appliances that may in any wise be deemed advisable in connection with the business of the Corporation or any branch thereof, or that may be deemed convenient by the Corporation at any time.
- 6. To do engineering and contracting in the designing, construction, improvement; extension, maintenance and repair of oil or gas plants, including pipe lines, tanks and other appliances thereto appertaining, and in the opening, developing and operating of petroleum, gas and oil wells.
  - 7. To manufacture, buy, sell and otherwise deal in gas and oil machinery and appliances.
- 8. To buy, sell, mortgage, lease, rent, exchange, hold, own, convey, assign, pledge, transfer, and in any manner acquire, improve, administer and dispose of real property, and any and every estate and interest therein; provided that the main purpose of business of the Corporation shall not be the acquisition or ownership of land by purchase, lease or otherwise.
- 9. To build, purchase, take in exchange, lease, charter, hire or otherwise acquire the ownership or use of, to navigate, operate as owner, charterer or managing operator, equip and man ships, vessels and aircraft of all types and classes, however propelled or with no propelling power, or sailing ships, together with all the equipment, stores, furniture and appurtenances thereof, docks, wharves, piers, basins, dry-docks, graving docks and floating dry-docks, works, shipyards, repair yards, salvage and towing craft and their equipment, oil terminals whether on land or off shore, and all other kinds of buildings, or structures on land or affoat used in connection with shipping or aviation, and to maintain, repair, improve, recondition, re-engine, convert, alter and to manufacture or otherwise acquire parts, tools, machinery, appliances and materials for, and to sell, exchange, mortgage, lease, let out on hire or charter or otherwise deal with and dispose of any of the items of property aforesaid.
- 10. To use and employ any of the ships, vessels, aircraft, buildings and structures above set forth and so built, acquired, owned, operated, leased, chartered or held, in any lawful business, trade, commerce or navigation and for the storing, loading, transportation and carriage of persons, property, goods and merchandise of every description, in bulk or otherwise, and packed in any containers, whether such property, goods and merchandise are owned
