SAM L. STEPHENSON, his heirs and assigns forever:

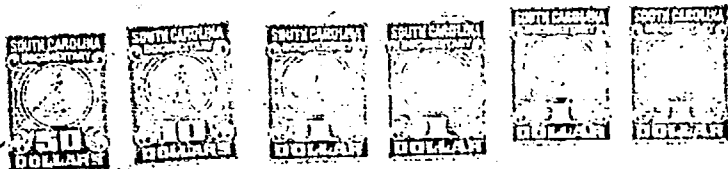
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the southwesterly side of Lullwater Road, in the City of Greenville, S. C., being shown as Lot No. 50 on the plat of Northside Gardens, as recorded in the RMC Office for Greenville County, in Plat Book S, page 17, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Lullwater Road, said pin being located 950 feet northwest of the westerly corner of the intersection of Lullwater Road and East North Street, and said pin being the joint front corner of Lots 49 and 50, and running thence along the joint line of said Lots S 52-47 W 232.5 feet to an iron pin, joint rear corner of said Lots; thence turning and running N 33-41 W 90.15 feet to an iron pin, joint rear corner of Lots 50 and 51; thence turning and running with the joint line of said Lots N 52-47 E 227 feet to an iron pin on the southwesterly side of Lullwater Road, joint front corner of said Lots; thence turning and running along the southwesterly side of Lullwater Road S 37-13 E 90 feet, to the point of beginning.
