

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released and by these

presents do grant, bargain, sell and release unto the said ROBERT C. DOBBINS and KAY M. DOBBINS, their heirs and assigns, forever:

ALL that certain piece, parcel or lot of land, lying, situate and being on the Westerly side of Elmhurst Road, near the City of Greenville, South Carolina, being shown and designated as Lot No. 32, Section II, Westcliff Subdivision, on a plat thereof recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book JJJ at Pages 72 through 75, and having, according to said plat, the following metes and bounds, towit:

BEGINNING at an iron pin on the Westerly side of Elmhurst Road, at the joint front corner of Lots 31 and 32, and running thence along the joint line of Lots 31 and 32, S. 39-32 W., 355 feet to an iron pin; thence along the joint line of Lots 32 and 199, N. 9-31 W., 290.3 feet to an iron pin; thence along the joint line of Lots 32 and 202, N. 57-02 E., 160 feet to an iron pin on the Westerly side of Elmhurst Road; thence along Elmhurst Road, S. 36-06 E., 70 feet to a point; thence continuing with Elmhurst Road, S. 48-26 E., 70 feet to the point of beginning.

THE GRANTEES herein agree and assume that balance due on the note and mortgage given by the grantors herein to First Federal Savings & Loan Association, dated September 1, 1972, in the original amount of \$31,050.00, recorded in the R.
