the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto


A. S. Painter, his Heirs and Assigns forever,

C., lying on the East side of Poplar Drive (formerly known as New Pelham Road), and on the north side of Pine Ridge Road, and being a part of the same property conveyed to me by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 543 at page 118, and having the following courses and distances, as shown on plat by H. S. Brockman, Surveyor, October 6th 1972:-
