All that certain piece, parcel or lot of land in McAlister Plaza, in the City of Greenville, County of Greenville, State of South Carolina, being that portion of the parking area lying between the property presently owned by the grantee herein and W. Antrim Drive and being bounded on either side by a straight extension of the side lines of the lot presently owned by the grantee to the southwesterly edge of the right of way for W. Antrim Drive and having according to the plat of Section No. 1, Portion of McAlister Plaza, prepared December 1961, most recently revised in August 1973, the following metes and bounds, to-wit:

BEGINNING at a point in the center line of a 10 foot water line easement, said point being located N 56-21 W 245 feet from the northwesterly edge of the right of way of Frederick Street and being the joint front corner of the lot belonging to the grantees herein with the lot belonging to George Watson Smith, Jr. and running thence along the front line of the lot belonging to the grantees herein N 56-21 W 51.1 feet to a point, joint front corner of the lot belonging to the grantees herein with the lot designated on said plat as belonging to Jean Jones Hipp; thence turning and running N 33-39 E 46.7 feet to a point on the southwesterly edge of the right of way of W. Antrim Drive; thence turning and running with the southwesterly edge of said right of way S 56-21 E 51.1 feet to a point; thence turning and running S 33-39 W 46.7 feet to the point of beginning.

This is a portion of that property conveyed to the grantor herein by deed of Charles A. Stokes, et al, recorded in the RMC Office for Greenville County, S. C., on December 31, 1960 in Deed Book 665, page 469.
