- 7. <u>Litigation</u>: To institute, prosecute, defend, compromise, arbitrate, and otherwise fully dispose of legal, equitable, or administrative hearings, actions; suits, attachments, arrests, distresses, or other proceedings, or otherwise engage in litigation in connection with the premises and the powers herein granted, except that my said atterney shall not be authorized to accept service of process from nor to submit me to the personal jurisdiction of any Court as a defendant in any suit or proceeding pending before the same without further specific, written authority on my part;

Subdelegation of Authority: To subdelegate any of the powers herein granted by appointment of any other person as my atterney, to emgage and discuss agents, counsel and employees, and to appoint and remove at pleasure any substitute for, or agent of my said attorney, in respect to all or any of the matters or things herein mentioned and upon such terms as my attorney shall think fit;
