- (5) S. H. BOWEN, dated October 5, 1967, for a primary term commencing March 25, 1968, and ending February 28, 1978.
- (6) BUTLER'S SHOE CORPORATION, dated February 3, 1967, for a primary term commencing March 18, 1968, and ending February 28, 1983.
- (7) Byrum & Bates, Inc., dated May 8, 1968, for a primary term commencing June 1, 1968, and ending May 30, 1978, assigned by Tenant to FAY A. CANNON, d/b/a Keyboard Music Center on February 17, 1970.
