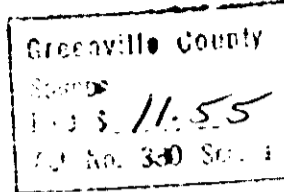

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Joseph M. Lammonds and Geraldine P. Lammonds, their heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 110 of a subdivision known as Pebble Creek, Phase I as shown on plat thereof prepared by Enwright Associates, Engineers, dated October 1973, and recorded in the R. M. C. Office for Greenville County in Plat Book 5-D at Page 4 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of the turnaround on Whittlin Way, joint front corner of Lots 109 and 110 and running thence with the joint line of said lots, S. 46-07 E. 136 feet to an iron pin in the line of a Duke Power Company right-of-way; thence with said right-of-way, N. 52-56 E. 190 feet to an iron pin at the rear corner of Lot 114; thence with the rear line of Lot 114 and continuing with the rear line of Lot 113, N. 46-30 W. 78.48 feet to an iron pin, joint rear corner of Lots 110 and 111; thence with the joint line of said lots, S. 79-45 W. 180.05 feet to an iron pin on Whittlin Way; thence with Whittlin Way, following the curvature thereof, the chord of which is S. 20-10 W. 45 feet to the beginning corner.

This conveyance is subject to restrictions and covenants being recorded in the R. M. C. Office for Greenville County in Deed Vol. 991 at Page 10 as well as any other restrictions, rights-of-way or easements that appear of record, on the plat referred to above or as shown on the premises.
