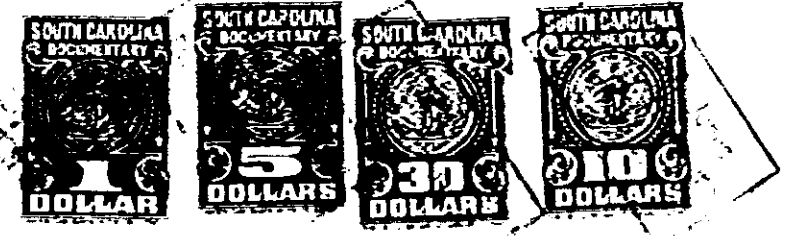
KNOW ALL MEN BY THESE PRESENTS, that I, William Edwin Pepper, of Greenville County
