in consideration of TWO THOUSAND SIX HUNDRED AND NO/100 (\$2,600.00)----- Dollars,

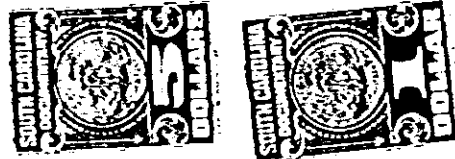
