



KNOW ALL MEN BY THESE PRESENTS, That **MARY ANN BENJAMIN, MARY LEE CHILDMORE,**
CHARLES J. COOPER, FRANCES WESTINGHALL
AND ROBERT BLACK ROBINSON

in the State aforesaid, in consideration of the sum of **SEVEN-HUNDRED THOUSAND AND FORTY-EIGHT DOLLARS**,
to them in hand paid at and before the sealing of these presents by
Darnest E. Black

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said ERNEST H. TOWN:

All that certain piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 1 on revision of the plat of the Estate of J. H. Palleger, made by Dalton & Neves, May, 1933, and being more particularly described as follows:

PEGINNING at an iron pin in the center of McCarter's Road, corner of a tract of 33.65 acres as shown on said plat, and running thence with line of said tract of land N. 90.67 W. 125 feet to a bunch; thence along said bunch S. 12- $\frac{1}{2}$ E. 126 feet to joint corner of Lots Nos. 1 and 2; thence along the line of Lot No. 2 N. 89-39 E. 716.1 feet to an iron pin on McCarter's Road; thence along the western side of McCarter's Road 125 feet to the point of beginning.

ALSO: All that other piece, parcel or lot of land in Chick Sardin's Township, Greenville County, State of South Carolina before known and designated as Lot No. 1 according to record of plat of the property of the Estate of J. R. Bellenger made May, 1913, and more particularly described as follows:

COMMENCING at a point in the center of McCarron's Mill Road and running N. 15-37 E., 17 rods east, to joint corner of lot line 760, 1 foot to joint rear corner of Lots Nos. 1 and 2; thence S. 10-37 E., 129 feet to joint rear corner of Lots Nos. 2 and 3; thence with the line of Lots Nos. 2 and 3 S. 7-37 E., 94 feet to the middle of said McCarron's Mill Road; thence in the center of said road in a northerly direction 145 feet, more or less, to the beginning point.
