in consideration of Twenty-one Thousand Nine Hundred and No/100 (\$21,900.00) -----Dollars,

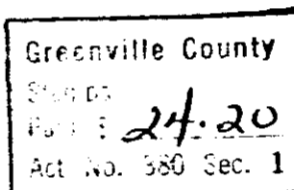
