(1) A Quitclaim Deed from me to Callie B. Shockley and Eva Shockley Grant covering 3.019 acres on a plat recorded in the RMC Office for Greenville County, S.C., in Plat Book 5G, page 159, of even date herewith to be recorded, and

(2) A deed from me to T. Stanley Hawkins covering a ten (10) foot alley to the rear of Lots 18 through 21 on the aforementioned plat of even date herewith to be recorded.
