ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, being shown on a Plat of Property of Frances S. Crosby, prepared by Carolina Engineering and Surveying Company, dated October, 1970, and recorded in Plat Book 4-J, Page 171, and containing 4.3 Acres, more or less, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Mill Road, also known as Coachman Drive, at the corner of a tract containing 3.8 Acres and running thence with the line of said tract, N. 41-04 E., 638.1 ft. to an iron pin in the line of a tract containing 8.2 Acres; running thence with the line of said tract, S. 38-35 E., 240 ft. to an iron pin at the corner of a tract containing 4.6 Acres; thence with the line of said tract, S. 29-06 W., 635.9 ft. to a point in the center of said Mill Road, also known as Coachman Drive; and running thence with the center of said Road, N. 61-45 W., 30 ft. to an iron pin; thence continuing with the center of said Road, N. 56-01 W., 151.2 ft. to an iron pin in said Road; thence continuing with the center of said Road, N. 33-25 W., 195.7 ft. to the point of beginning.
