R. L. Rucker and Susan F. Rucker, their heirs and assigns, forever:

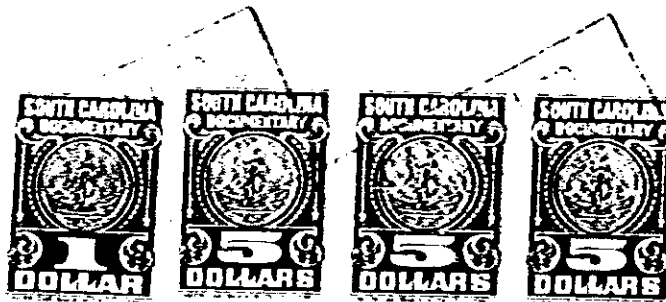
