THIS INSTRUMENT, made and entered into this 10th day of May, 1975, by and among DAN E. BRUCE, FELIX G. BUCHANAN, and DAVID W. GLENN, all being residents of Greenville County, South Carolina, hereinafter referred to as "Partner" or "Partners".

WITNESSETH:

WHEREAS, the Partners formed a General Partnership under the name of BGB CO. which acquired and owned an interest in and participated as a General Partner in Holly Tree Plantation, a Limited Partnership as evidenced by a Memorandum thereof appearing in the R. M. C. Office for Greenville County, South Carolina, in Deed Book 1002 at page 457.

WHEREAS, the Partners have agreed to dissolve the Partnership known as the BGB CO.

NOW, THEREFORE, for and in consideration of the sum of \$1.00 the Partners do hereby confirm and acknowledge that the Partnership of BGB CO. is dissolved and shall be terminated in full effective on the date on which the Fourth Amendment to the Holly Tree Plantation Limited Partnership is filed in the Office of the Clerk of Court for Greenville County, South Carolina and the Secretary of State for South Carolina acknowledging that BGB CO. has withdrawn and retired as a General Partner in the Holly Tree Plantation Limited Partnership. The terms and conditions contained herein are a Memorandum of and incorporated by reference in that certain agreement between the undersigned parties as Partners dissolving and terminating the BGB CO., Partnership of even date herewith incorporated herein by reference thereto.
