to all easements, rights of way or restrictions of record.

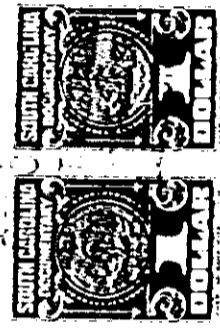
