in consideration of \$10.00 and other valuable consideration ----- Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto John A. Bolen, Inc., its successors and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being in the state of South Carolina, County of Greenville, being known and designated as Lot No. 5 of a subdivision known as Canebrake I as shown on plat thereof prepared by Enwright, Associates dated August 18, 1975, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5D, at Pages 95 and 96 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Canebrake Drive, joint front corner of Lots 4 and 5; running thence with the joint line of said lots N. 36-47 W. 142.72 feet to an iron pin; thence N. 52-21 E. 85 feet to an iron pin, joint rear corner of Lots 5 and 6; thence with the joint line of said lots S. 37-13 E. 156.60 feet to an iron pin on the northwestern side of Canebrake Drive; thence with the northwestern side of Canebrake Drive in a southwesterly direction, following the curvature thereof, an arc distance of 87.01 feet to the BEGINNING corner (the radius being 1850 feet).
