S. Highway No. 25); thence with the Eastern edge of the right of way for the said Augusta Road S. 8-23-00 W. 79 feet to an iron pin at the joint rear corner of Lots Nos. 5 and 6; thence with the line of Lot No. 6 S. 87-55-30 E. 117.83 feet to an iron pin on the Western side of Sheffield Drive; thence with the curve of the Western side of Sheffield Drive, the chord of which is N. 2-12-54 E. 60.08 feet to the point of beginning.
