in consideration of Seventeen Thousand, Five Hundred and No/100 (\$17,500.00) ----- Dollars,

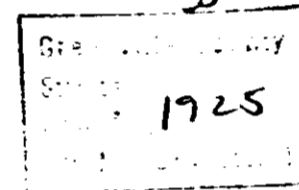
