ALL that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the southern side of Verner Drive, being known and designated as Lot #22, as shown on a plat of Cedar Vale, recorded in the R.M.C. Office for Greenville County, in Plat Book 000, at Page 13, and as shown on a Plat of Addition to Cedar Vale, made February 28, 1968, and recorded in the R.M.C. 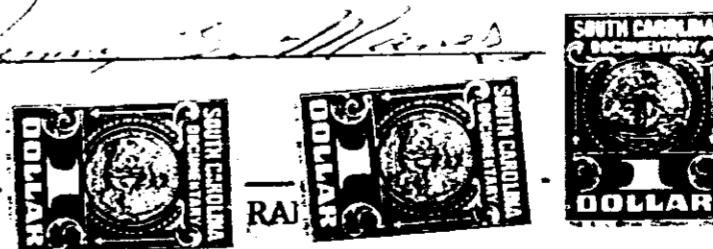
