COTHRAN & DARBY BUILDERS, INC., its Successors and Assigns Forever:

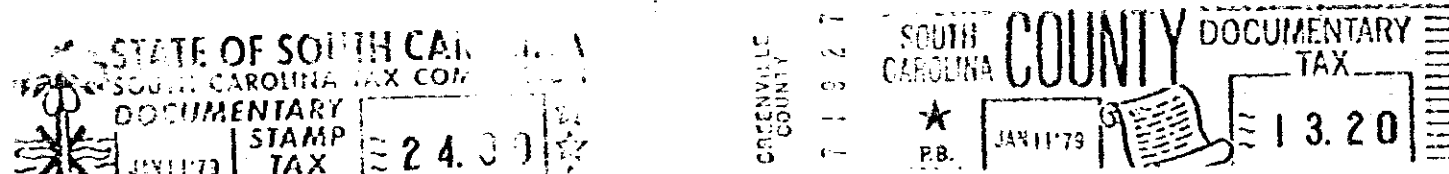

BEGINNING at an iron pin on the Southeasterly side of Cliffwood Court said pin being the joint front corner of Lot Nos. 362 and 363 and running thence with the common line of said lots S. 25-25 E. 169.95 feet to an iron pin the joint rear corner of Lot Nos. 362 and 363; thence N. 36-05 E. 156.73 feet to an iron pin the joint rear corner of Lot Nos. 361 and 362; thence with the common line of said lots N. 53-55 W. 140 feet to an iron pin on the Southeasterly side of Cliffwood Court; thence with the Southeasterly side of Cliffwood Court S. 36-05 W. 40 feet to an iron pin; thence continuing with said court on a curve the chord of which is S. 50-20 W. 36.93 feet to an iron pin the point of beginning.
