the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents, do grant, bargain, sell, and release unto Willa C. Cole, her heirs and assigns forever;

ALL that piece, parcel or lot of land in the County of Greenville, State of South Carolina, situate, lying and being on the western side of Fork Shoals Road (S.C. Highway 23-146) and being a portion of the R. A. Johnson Estate and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Fork Shoals Road, joint corner of the within described property and a road leading to Ashmore Fish Pond and running thence with the western side of Fork Shoals Road, 101 feet, more or less, to the joint common corner of the within described property and that property formerly deeded to Grantee by the Grantors; thence with the common line of the Grantors and Grantee, S.77-44 W. 360 feet, more or less, to an iron pin; thence N.13-20 W. 132 feet, more or less, to a point on a road leading to Ashmore Fish Pond; thence with the southern side of said Road, S.81-30 W. 361 feet, more or less, to the point of beginning. - 80 - P.T.O.F. 583.2 - 1 - 29.1 -> 2.25 AC
