ALL that certain piece, parcel or tract of land in Greer, South Carolina, on the northwestern side of Middleton Drive, in Greenville County, S. C., being shown and designated according to a plat entitled "Property of Investments Diversified Limited" dated November 1976, prepared by Dalton & Neves Co., Engineers, which plat is recorded in the RMC Office for Greenville County in Plats Book 6-2, at Page 92, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Middleton Drive at the joint corner of property belonging to Mr. Zip, Inc., and running thence N. 67-38 E. 299.3 feet to an iron pin; thence N. 22-35 W. 121.26 feet to an iron pin; thence S. 67-48 W. 306.6 feet to an iron pin on Middleton Drive; thence with the right of way of Middleton Drive S. 25-59 W. 122.4 feet to an iron pin, the point of beginning. — 285 - G 12 - 1 - 2 → 0.946 AC

RESERVING, HOWEVER, unto the Grantors, their heirs and assigns forever, an easement over a ten-foot strip thereof, as shown on said plat, for the purpose of installation and maintenance of water lines and utility lines. No permanent structure of any nature shall be built over, onto or across this area.
