Shell hereby acknowledges that neither (a) Stafac's conveyance of the Released Premises to Shell by its Limited Warranty Deed dated MARCH 19, 19% nor (b) the consequent release of the Released Premises from the Lease, by merger in Shell of both the fee and the leasehold estates therein, nor (c) this Release of the Assignment and the Indenture with respect to the Released Premises, does or shall release or affect in any way the Lease, the Assignment or the Indenture with respect to any premises subject thereto, other than the Released Premises.
