All that piece, parcel or lot of land, situate, lying and being on the northern side of Henderson Road, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 7 as shown on "Re-Plat of Property of Joe W. Hiller, et al", said plat dated June 14, 1968 and recorded in Plat Book PPP at page 62 in the RMC Office for Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:
