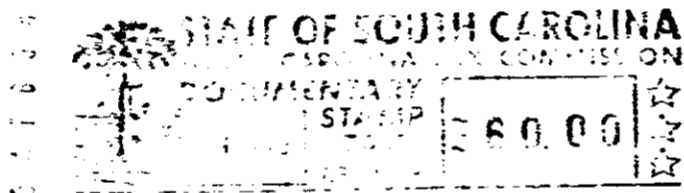
KNOW ALL MEN BY THESE PRESENTS, that Joe G. Thomason and Gary F. Forte

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release

ALL that piece, parcel or lot of land with all buildings and improvements thereon, situate, lying and being on the southern corner of the intersection of Haviland Avenue with Beechwood Avenue in the City of Greenville, Greenville County, South Carolina, being known and designated as Lot No. 11 as shown on a plat entitled DAVIS PROPERTY made by R. K. Campbell and J. L. Hunter, Surveyors, dated July, 1951, recorded in the R.M.C.
