DILLARD NEIL FLEMING AND RHONDA S. FLEMING, THEIR HEIRS & ASSIGNS FOREVER:

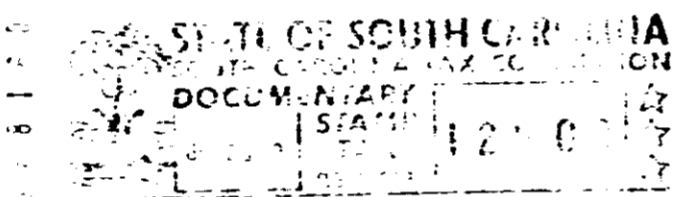
