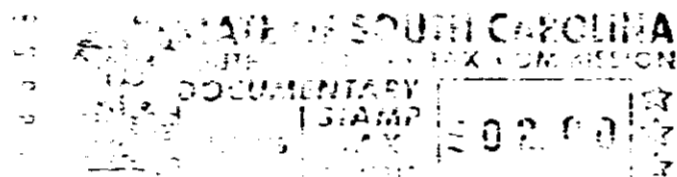

All that certain piece, parcel, or tract of land in the County of Greenville, State of South Carolina, being shown and designated as 0.504 acres, on Plat for Garry N. Stewart, prepared by Webb Surveying & Mapping Co., May, 1979, recorded in the RMC Office for Greenville County, S. C., in Plat Book "7-H", at Page 91, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin, 210 feet from County Road, joint corner of property of Henry A. Stewart, and running thence with line of Stewart property, N. 54-31 W. 105.0 feet to an iron pin in line of other property of grantor; thence with line of property of grantor, N. 30-01 E. 210.63 feet to an iron pin; thence continuing with other property of grantor, S. 54-10 E. 105.0 feet to an iron pin in line of other property of grantee; thence with line of property of grantee, S. 29-30 W. 210 feet to an iron pin, the point of BEGINNING.
