ALL that certain piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot 53 of a subdivision known as Brookwood Forest, Section II as shown on a plat of a portion of said subdivision prepared by Webb Surveying & Mapping Co., recorded in the R.M.C.
